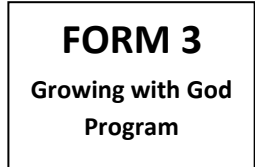

SAFE ENVIRONMENT PROGRAM  
Training Report for Children & Youth**



**Purpose: To document the teaching of annual safe environment training to all students in Catholic grade schools.**

**Directions:**

1. In the table, list all the sessions in which the training is presented to the children. Add rows if needed.
2. For each session, provide the date of the session, grade level of students, number of students present, number of students absent, number of students whose parents opted them out, the presenter's name. If parents train their children at home after being absent from the school session, enter them in the row for at home learning. Do not include them in the absent count for the in-person training at the school. This would double count the number of students.
3. Do not include other safety curriculum on this page.
4. Total the numbers in each column.
5. Page 3, Line a – Enter the total number of students who received the safe environment sessions either in person at school or if absent, at home by parents.
6. Line b – Enter the total number of students who were absent and could not make up the session. (Note: for these students, send a copy of the material to the parents with a request that they review it with their child). If the parents return the form that they reviewed the material at home, then include these students in in the row for at home training.
7. Line c – Enter the number whose parents did not want them to attend (opt outs), if there were any. (Note: for these students, offer/send a copy of the material to the parents with a request that they review it with their child). Each parent must sign a **PARENT REFUSAL FORM**. Please keep all these forms on file.
8. Line d – Enter the number of students who left the school, enrolled after training or any other number necessary to make your total add correctly on the next line.
9. Line e -- Enter the total number of children enrolled in your school. Please make sure this number equals the sum of the four numbers above it!
10. Please complete the information at the bottom of the page and review it with the pastor of the parish.
